Public Service Announcement

PSA's are persuasive commercials designed to grab the reader's attention, to inform them, and to get them to act. PSA's can cover a variety of topics from staying away from drugs, to playing 60 minutes a day to promote a healthy lifestyle. Your assignment is to create a PSA containing the following elements

Length: 45 seconds- 2 minutes

Voice: Your voice must present material in your PSA

Visuals: Your PSA must contain facts, statistics, charts, and graphs

Music: Your PSA must contain a song that connects to the viewer or topic Subtitles: Your PSA must contain words that appear on the screen or slide

Connection: You must connect your message to the D of I, B of R, or U.S. Const.

Tips: You could complete this project by creating a timed powerpoint presentation, or by creating a PSA using SPLICE, IMOVIE, or MOVIEMAKER.
